

# Want To Perform Remote Online Notarizations?

As of January 1, 2020, a commissioned Florida Notary Public may register to perform remote online notarizations (RONs) using an audio-video technology provider that is compliant with Florida law.

## How Can I Become A Remote Online Notary?

If you would like to register as a remote online notary, simply complete the order form below. For your convenience, the required \$25,000 notary bond and remote online notary course has been pre-filled below. **Calculate the premium for the required Errors and Omission policy.** For example, if you have 21 months left on your commission, premium of  $\$1.04/m \times 21 = \$21.84$ . Once the order form is completed, scan and email, fax or mail it with payment to **Budget Notary Services.**

Your bond and E&O policy will be emailed to you within one business day along with instructions for completing the registration process at the State. If you are purchasing a replacement commission certificate, it will be mailed to you within one business day upon receipt from the State.
